



Consignment Agreement and Policies

Welcome to Couture Kids! We are so looking forward to our new relationship! We are also so thrilled to have you as a new consignor! Here is all the information you will need to get started.

1 ~ Items will be accepted during Store Hours ~ 30 minutes after opening & 30 minutes before closing. Not on Sundays. **Items MUST be in READY-TO-SELL-CONDITION!** If we are not able to go over your items at that time, because we are with a customer, we will call you if there are items to be picked up. You have 1 week after we contact you to pick-up your items. After such time they will be donated. We don't have room to store non-consignment items. _____.

2 ~ The better your clothes look and condition they are in the higher price we can get for them. Clothes must be **freshly laundered, pressed & in season.** They must also be smoke & pet hair free with no stains and in excellent condition. We prefer you to bring your clothes in on hangers ~ we have hangers you can take. Your hangers WILL NOT be returned to you. **We will only accept items we know our customers will buy. We are very particular about the items we sell ~ that is why you want to shop with us!** Sometimes there will be items we can't accept because our customers will not buy them. If you have any questions about your potential consignment items ~ please feel free to call us. **We will accept a Maximum of 20 items per day.**

3 ~ **Couture Kids** sets the price of all items.

4 ~ **Consignment period is 60 days. Starting when the items are placed on the floor to sell.** **Couture Kids** pays you, the consignor, 40% of the selling price of all items selling for less than \$50. The Consignor will be paid 50% of the selling price for all items selling for more than \$50. The 'selling price' is the ticket price minus any inventory handling & pricing fee. The handling & pricing fee is paid by the buyer NOT the consignor. _____.

5 ~ PAYMENT for items sold may be picked up the 2nd & 4th Friday of the month, ONLY! You contact us. **We are unable to return emails about payouts each month.** We now have hundreds of consignors. Payment is for items sold in the previous month. **Money/payout needs to be collected within six (6) months of items being sold.** It is forfeited after that time. (Consignment records are archived every 6 months). _____.

6 ~ **Couture Kids** is not responsible for merchandise that is damaged, lost or stolen while on the premises. We value you and your merchandise and will do our best to safeguard your items.

7 ~ Couture Kids has the right to put items on sale at times deemed necessary. Our duty is also to you, our consignors. Part of that job is getting you the greatest return for your wonderful valued clothes. The sales & markdowns are shared equally by **Couture Kids** & the consignor.

8 ~ **All Items not sold at the end of the Consignment Period ~ 60 days ~ become the property of Couture Kids, unless otherwise stated by the Consignor and agreed to by Couture Kids** Items picked up BEFORE the end of the Consignment period will incur a \$1 per item charge. _____.
